Rules and Regulations: SAFETY is first and foremost. FAIRNESS to all participants is just as important.

ELEMENTARY TEACHERS: The most frequent infractions occur with Rules 1 through 6. Share with students!

Proper attention to safety is expected of all participants, including compliance with the following requirements:

If you do not understand a rule, please ask. Contact inventors @edisonfairs.org in advance.

Do not wait until the week of the fair.

General Rules: At first some of the rules will seem unnecessary or harsh. Please give a little extra thought to first impressions. Safer methods are shared that may even be more reliable and save time.

- 1. Each participant will be allowed a 32 inch by 18 inch display area. A tri-section display board is recommended and must be stable. (See dimensions below) The space directly underneath the exhibit table may be used.
- 2. **NO** oversized exhibits or large floor models. (Aisle space must be free from objects protruding from under tables.) Smaller models, photos, illustrations or videos are suggested in place of over sized prototypes.
- **3. NO live animals** are allowed to be part of an invention exhibit. (Inanimate models, photos, illustrations and videos may be used.) The presence of a service animal will require advanced notification to administrators. The exhibit hall can get crowded and stress even a service animal. Allergies and phobias require precautions.
- 4. NO awards, medals, endorsements or acknowledgements from previous fairs.
- 5. NO Electrical outlet access. No open-top cell batteries allowed.
- 6. **NO foods, liquids, powders, plants and soils**. Potential health or physical hazards inclusive of toxic chemicals, potential allergens, or microorganisms are not allowed.
- 7. NO laboratory/household chemicals, poisons, drugs, controlled substances, hazardous substances or devices (for example: firearms, weapons, ammunition, reloading devices, model rockets).
- 8. NO sharp items (for example: syringes, needles, pipettes, knives)
- 9. NO flames, open or concealed, or highly flammable materials
- 10. NO gases or empty tanks previously containing combustible liquids or gases, including butane or propane.
- 11. NO preserved tissues or body parts, human or animal.
- 12. NO photographs or other visual presentations of animal surgeries or dissections
- 13. **Avoid all brand names, logos or acknowledgements OTHER THAN YOUR OWN**, unless written permission has been granted from the owners of the intellectual property.
- 14. No hand-held laser pointers of any power. No operation of Class III or Class IV lasers

Exhibit table space

Width (side to side): 32 inches (81 centimeters)

Depth (front to back): 18 inches (45 centimeters)

Area directly under this table space may be used for storing prototypes/models

Ideal Size of Physical Tri-fold Display Board - must be stable

Depth (front to back): 18 inches (45 centimeters)

Width (side to side): 48 inches (122 centimeters) full opened. Display in the exhibit space with sides folded. **Height** (floor to top): preferably 36 inches (91centimeters); Regional maximum 72 inches (182 centimeters)

Brace A stabilizing brace with side panel slots may be helpful to bridge across the span.

Displayed Items

- 1. **Logbook/workbook** should be displayed with your project.
- 2. **Prototype** must be of a size to fit within the 32" x 18" exhibit table space provided. If too small to view, use illustrations, photos, and/or videos to demonstrate. If too large to fit, make a smaller model or use illustrations, photos, and/or videos to demonstrate.

3. Display Board: To be fair to all participants oversized displays will be penalized points to be determined by the magnitude of the infraction. If unsafe, disqualification will be required.

Display Safety Requirements

Proper attention to safety is expected of all participants, including compliance with the following requirements:

- 1. Properly fasten all structural components. Nails, tacks, or unshielded staples are not acceptable.
- 2. Permissible battery operated equipment include: Computer Laptops and Tablets, Smart or Cell phones.
- 3. Operation of any equipment or devices other than those shared in #3 shall be shared by video, photos, or illustrations.
- 4. Avoid any items placed in the isle or protruding into the isle.

Edison Fairs Display & Safety Inspectors will disqualify any exhibit which does not comply with all preceding Project Display Rules. Fair Directors may be requested to confirm the inspector's decision.

Loss or Damage

EDISON FAIRS and FACILITY SERVING AS THE VENUE FOR THE FAIRS assumes no responsibility for loss or damage to any project or project part. Valuable items should be simulated or removed when the student is not present at his/her project.

Regulations to Participate

The Events are open only to K-12 students.
